- Hold public liability insurance for the activities proposed in this form for a value no less than NZD\$10 million.

Non-Domesticated Animals

- The Operator will be competent in handling animals, control and monitor animals at all times and supervise interactions with the public.
- Animals will be restrained or contained appropriately to ensure there is no direct access to the public e.g. cage or barrier.
- There will generally be no direct interaction between animal/s and public permitted including petting. Further details may be required, depending to the type of animal/s if petting is part of the display.
- Animal waste will be disposed of appropriately with consideration to public health and the environment.
- Relevant animal protection and welfare requirements will be complied with.

- Animals will be removed from the premises overnight.
- Appropriate shelter, food and water will be provided for the animals.
- A minimum distance of three metres will be maintained between animals and food service.
- The Operator will have a re-capture plan in case of animal/s becoming uncontained.
- An Animal Management Procedure stating how the animal(s) will be cared for on site.
- Hold public liability insurance for the activities proposed in this form for a value no less than NZD\$10 million.
