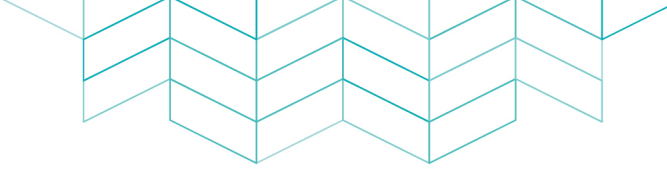

- All candles will be located within an appropriate container to capture melting wax. Incense burning should be in a container to catch any falling ash.
- Naked flames and hot surfaces will be located in such a manner that they are clear of all flammable surfaces and cannot be knocked over.
- Signage advising persons of a hot surface will be displayed adjacent to any fireplace or hot surface.
- Any fireplace will be compliant with relevant manufacturing standards.
- Fireplaces will be operated as per the manufacturer's instructions.

# Naked Flames



- Naked flames will be monitored at all times; under no circumstances will a stand be unattended whilst a naked flame is lit.
- All naked flames will be extinguished 15 minutes before show closes each day.
- Smoke isolation will be obtained where required. Please contact your Event Coordinator to arrange.
- An appropriate fire extinguisher will be located on the stand. The staff on the stand are trained on the correct operation and application of the fire extinguisher.
- If LPG is being used, a Hazardous Substances permit will be required to also be submitted.
- Hold public liability insurance for the activities proposed in this form for a value no less than NZD\$10 million.

## Required Documentation

These documents, and any other documents as requested, must be provided to Te Pae Christchurch with this completed application form.
