	Protection is provided for all floor surfaces e.g., carpet and stage pieces that come into direct contact with pyrotechnics residue.						
	The licensed pyrotechnician will give reasonable directions to any member of the event staff in order to maintain a safe working environment.						
	No pyrotechnics or devices will be used that will result in pyrotechnic effects above the audience and/or seating.						
	All pyrotechnic devices will be located at least their designated throw distance from combustible props used on stage.						
	Pyrotechnics are handled in line with the Hazardous Substances (Fireworks, Safety Ammunition, and Other Explosives Transfer) Regulations 2003. A <u>Hazardous Substances permit</u> will also need to be submitted with this application.						
	WorkSafe New Zealand is notified of the intended display.						
	The work will only be carried out between the approved hours specified on this application.						
	If conditions or controls change, the work will cease to continue, and a re-assessment will be conducted using a Job Safety Environmental Analysis (JSEA).						
	Hold public liability insurance for the activities proposed in this form for a value no less than NZD\$10 million.
