- Vehicles will be accurately placed according to the appointed location(s) on the pre-approved floor plan.
- Vehicles will have floor protection placed if sharp turns or wheel turning is anticipated. The exhibitor or client accepts charges for any damage to venue flooring.
- All vehicles that are displayed on a gradient (e.g., one set of wheels on a ramp) will be locked and no access granted unless removing the vehicle from the display. If the display has the vehicle totally off the floor, chains or straps will be used to secure the vehicle for added safety.
