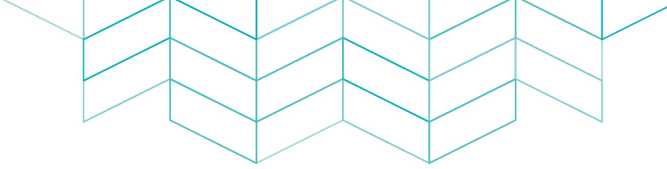

- Weapons/sharp implements/props sold to the public are to be security sealed upon purchase. The item will only be provided to the purchaser upon leaving the building. Weapons or props, once removed from any sealed packaging, will not be allowed back into the venue.
